

Beginning July 1, 2022, the asset (property) limits for Medi-Cal increased!!!

Asset Limit Beginning July 1st: \$130,000 Single and \$195,000 Couples

Senior Medicare Patrol:







While Medicare Advantage (MA) plans, comprising about 40% of Medicare beneficiaries, report high consumer satisfaction, some of the insurers have come under criticism for allegedly aggressive and misleading sales tactics and failing to provide adequate coverage for beneficiaries. In 2021 the SMP program saw a 24% increase in marketing complaints over the prior year. Complaints are expected to spike like they always do during Open Enrollment. The key is for beneficiaries to



educate themselves before enrolling in an MA plan. Each state has a State Health Insurance Assistance Program, or SHIP, that provides free help for people considering their Medicare options.
